### Process Before

1. Buy A4 Pink Form from Authorised Organisation (SCCCI).
2. Print / type on A4 Pink Form at office, re-printing / re-typing when necessary
3. Courier / travel down to SCCCI to provide A4 Pink Form and supporting documents
4. Wait several hours
5. Courier / collect from SCCCI

### Process After

1. Create and submit CO online
2. SCCCI approves and prints out on A4 Pink Form or on A4 white paper (or choose to print at your office if digital signatures suffice)
3. Courier / collect once you receive notification that it is ready for collection at SCCCI

→ **Save on costs and time – you can expect a 60% time-savings, and 1.5X in productivity gains.**
