# SCCCI Business Mission to Vietnam Hanoi & Ho Chi Minh City

6th - 10th March 2023

The MPI performs the functions of state management over planning, development investment, and statistics, including the provision of general advice on strategies, plans for national socio-economic development; on development planning, mechanism and policies for general economic management and some specific fields; on domestic investment, foreign investment into Vietnam and Vietnam's investment abroad; economic zones (including industrial parks, border-gate economic zones, hi-tech parks and other types of economic zones).
