

# SCCCI Business Mission to MALAYSIA

(Kuala Lumpur, Ipoh and Penang)

Malaysia, being one of the top destinations for Singaporean businesses, offers numerous opportunities, geographic advantages, and a business-friendly environment. The country serves as a valuable partner for collaboration, innovation, and growth, providing the potential for increased market share and strategic expansion within the region for Singaporean companies.

Led by the President of the Singapore Chinese Chamber of Commerce & Industry (SCCCI), Mr Kho Choon Keng, SCCCI is organising a 5-day Business Mission to Malaysia, covering Kuala Lumpur, Ipoh, and Penang. This mission will be held in conjunction with the Malaysia-Singapore Chinese Chambers of Commerce Business Forum and Corporate Visit 2025. The objective of this mission is to explore and understand the business landscape and opportunities in the country, with the following goals:

- (c) SCCCI reserves the right, without prior notice, to make changes and/or amendments to the Mission programme, in part or in whole for the Mission, as it deems fit or as the circumstances dictate.
- (d) Mission participants who make their own flight and hotel accommodation arrangements are strongly advised to update themselves with the latest programme and ensure that they meet up with the main group punctually at the designated locations.   - d. Cancellations received less than 15 days prior to departure, Participants liable to pay full sum of the common fund. Administrative fees are non-refundable.
