Media Statement

SCCCI and ACCCIM Establishing a Joint Steering Committee for Cooperation and Consultation (JSCCC) for Fostering Greater Economic Cooperation Among Singaporean and Malaysian Members

1. The Singapore Chinese Chamber of Commerce & Industry (SCCCI) and the Associated Chinese Chambers of Commerce and Industry of Malaysia (ACCCIM) have jointly announced the establishment of a **Joint Steering Committee for Cooperation and Consultation (JSCCC)** with immediate effect. This is an ongoing effort to strengthen the enduring ties and economic relations between the two chambers. The key objective is to help our member companies leverage complementary strengths of Singapore and Malaysia to drive business development and growth. This marks a groundbreaking milestone in cementing our strong, strategic, and long-term partnership of the two chambers.

2. Building upon the foundation of our longstanding collaboration, SCCCI and ACCCIM recognize that it is crucial and timely to harness the growth opportunities that arise from the rapidly evolving post-Covid economic and business landscape. With this shared vision, the two Chambers inked a forward-looking Memorandum of Understanding (MOU) ^[1] on 30 January 2023 to catalyze business collaboration and joint investment in thriving areas of sustainability, digitalisation, finance, tourism, green economy, renewable energy, food security and critical resources. We are confident that these business ventures will contribute towards strengthening stronger economic ties between Singapore and Malaysia.

3. Both Chambers have been hosting annual business forum in both countries alternately to share perspectives and explore business opportunities. The 17th Annual Singapore-Malaysia Chinese Chambers of Commerce Business Forum was held in Singapore on 18 November 2023. Close to 200 business leaders from Singapore and Malaysia participated at the forum. It was a robust sharing and incisive discussion on ideas to operationalize the envisaged initiatives under the MOU.





4. As a follow-up to the successful forum, top leaders of SCCCI and ACCCIM have agreed to establish the **Joint Steering Committee for Cooperation and Consultation** (**JSCCC**). The **JSCCC** serves to achieve the following:

- (a) Spearheading the actionable areas of collaboration encapsulated within the MOU;
- (b) Facilitating deeper business partnership and greater investment opportunities for our members in both Singapore and Malaysia;
- (c) Fostering collaboration to tap the emerging investment opportunities in Southeast Asia by leveraging government's initiatives, including the Malaysia-Singapore Business Development Fund; and
- (d) Serving as a conduit to share feedback and ideas as well as offer recommendations to our respective governments on policies, rules, and regulations with a view to enhance the business operating environment across Singapore and Malaysia. These include creating conducive business ecosystem, enhancing efficiency, strengthening physical and digital connectivity, and facilitating cross-border flow of goods and people to maximize business synergies.

The **JSCCC** will comprise senior leadership from both Chambers, co-led by President of SCCCI Mr Kho Choon Keng and President of ACCCIM Senator Tan Sri Dato' Low Kian Chuan.

5. SCCCI President Mr Kho Choon Keng said, "SCCCI and ACCCIM have very close working relationship and strong mutual trust that has been established over the years. The **JSCCC** will enable us to cooperate and consult each other regularly in complement with our governments to proactively seize and materialize business opportunities. Beyond this, we hope that our collaboration can serve as a model of how businesses within Southeast Asia can harness our respective strengths and complement one another to deliver benefits to our people and our economies."





6. ACCCIM President Senator Tan Sri Dato' Low Kian Chuan views positively about this initiative, and said that "Malaysia and Singapore have a close, deep-rooted, comprehensive and symbiotic relations that continued to grow from strength to strength, forged by proximity and strengthened by historical, cultural and familial ties. We believe that the establishment of the **JSCCC** not only will unlock enormous opportunities for greater collaboration among our members, but also help to elevate both countries' competitive economic position in the region. Both countries' businesses and companies can further strengthen and leverage our competitive advantages for a win-win outcome. This would reinforce our strategic location to tap wider markets and gain further international footprint via RCEP and CPTPP platforms."

7. The **JSCCC** will strive to meet at least twice a year. Both Chambers firmly believe that this significant partnership would underscore our shared commitment to catalyze sustainable business development, bring value to our members and the business community, as well as contribute to the economic developments of Singapore, Malaysia, and beyond to Southeast Asia.
